On July 1, 1999, San Diego Center for Jewish Culture ("CJC") entered into an agreement with LFJCC to administer the cultural arts programs and complex for the CJC. LFJCC is entitled to retain any positive results from operations and is responsible for any negative results from operations. LFJCC absorbed \$118,836 of CJC's operations for the year ended June 30, 2016.
